I also served for many years as the vice president of our faculty association which meant that I co-chaired the college academic decision making body with the academic vice president of the college. I did also win a number of teaching awards from the college. In addition, I was the author of two psychology textbook instructor manuals. One was an introductory text and the other was in social psychology.
